I am in receipt of your request for information from the Mount Vernon Police Department as a part of the SEQRA process for the Proposed Downtown Transit-Oriented Arts District, located at and around 20 South 2nd Avenue in the City of Mount Vernon. Please see below the information asked for in your letter:

Number of Personnel in the City of Mount Vernon Police Department:

• The Department has an authorized strength of 208 Police Officers, however, as of the date of this letter, we have 192 Officers on staff. We have an authorized strength of 66 Civilians / Support Staff; however we currently have 53 Civilian employees on staff.

Response time to the Project Site:

• Since the locations of responding Police Officers are dynamic due to their non-stationary response locations, it is difficult to state with certainty the response time to the Project Site, however I will point out that the site is approximately 1,500 feet from the front of Mount Vernon Police Headquarters, allowing for a non-emergency response of approximately 2-3 minutes and an emergency response of less than one minute (assuming the first responding unit is in service and at Headquarters).

The number and types of equipment available:

• On a regular tour of duty, we have at least 9 police cars, staffed with 8 officers and two additional Supervisors available to response. There is also a very highly trained and equipped Emergency Services Unit, staffed with an additional 2 officers available for response to high priority SWAT type calls.

The total number and types of calls received in 2020 and 2021:

• We have this information listed on our website (pd.cmvny.com/PDinfo) within the Annual Reports, Monthly Crime Statistics and Incident Statistics tabs. Due to the large amount of information, it is easier to redirect you to the website instead of trying to list it on this letter.



As part of the State Environmental Quality Review Act (SEQRA) process and in conformance with the DEIS Scope promulgated by the Lead Agency, the Mount Vernon City Council, the environmental review is to include information on and potential impacts to community services and facilities, including fire protection services, and we would appreciate your assistance in this regard. At your earliest convenience, we are respectfully requesting the following information to assist in our review:

- 1. Please confirm the current number of full-time personnel within the Mount Vernon Fire Department
- 2. The number and type of Fire Department vehicles
- 3. Please confirm which of the department's four fire houses would serve as the first response fire house for the Project Site
- 4. The estimated response time to the Project Site
- 5. Total number of annual fire calls per year for the last three years

- 6. Currently proposed improvements to the Fire Department (e.g., addition of vehicles, addition/expansion of existing facilities, new facilities) and the timing of such improvements, if any
- 7. Current ISO rating
- 8. Mutual aid agreements currently in effect
- 9. Any other pertinent information that you believe to be relevant to the environmental review, including the ability of the Fire Department of Mount Vernon to serve the proposed development

In regards to emergency medical services and ambulance transport, we are respectfully requesting the following information to assist in our review:

- 1. The locations of the stations/substations of the Fire Department of Mount Vernon, and those which would serve the proposed development, as well as the estimated response time to the Project Site
- 2. Total number of rescue/EMS calls per year for the last three years
- 3. Hospitals/medical facilities to where patients are brought by EMS
- 4. Primary funding sources for EMS/ambulance services
- 5. Any other pertinent information that you believe to be relevant to the environmental review


