WHEREAS, an application for property located north of the Westchester Medical Center on land bounded by Old Saw Mill River Road, West Stevens Avenue, Sprain Brook Parkway, Hospital Road and Nilsson Drive, Valhalla, has been filed with the Town of Mount Pleasant, located in Westchester County, New York, by Fareri Associates LP/North 80 LLC and Holly Hill Lane, LLC; and

WHEREAS, the proposed action involves the development of a mixed-use community consisting of approximately 3 million square feet of bio-tech/research and development related uses including medical offices, a children's living science education center, neighborhood retail and a hotel as part of a comprehensive Master Development Plan. The proposed action also includes an amendment of the OB-5 – Office Building zoning district, rezoning the site, subdivision approval, review and approval of a Master Development Plan and site plan approval for Phase 1 of the Master Development Plan.

WHEREAS, pursuant to 6NYCRR Part 617, the proposed development of the site as described above is classified as a Type I Action; and

WHEREAS, in accordance with the provisions of 6NYCRR Part 617.6, the Planning Board of the Town of Mount Pleasant intends to serve as Lead Agency for the SEQRA Review of this Type I Action, and in this capacity, will determine if the proposed action will have a significant effect on the environment; and


WHEREAS, pursuant to the requirements of 6 NYCRR Part 617.6 (b) (3) a Coordinated Review of this action will be conducted.

NOW THEREFORE BE IT RESOLVED, that the Planning Board of the Town of Mount Pleasant hereby designates its intention to serve as Lead Agency for the SEQRA Coordinated Review of this Unlisted Action, and directs the applicant to circulate this Lead Agency Notice, along with the Environmental Assessment Form and associated documentation, to all Involved Agencies. Involved Agencies shall be given 30 days from the mailing of the Lead Agency Notice to challenge the Planning Board's designation.

BE IT FINALLY RESOLVED, that this resolution shall have an effective date of March 18, 2019.

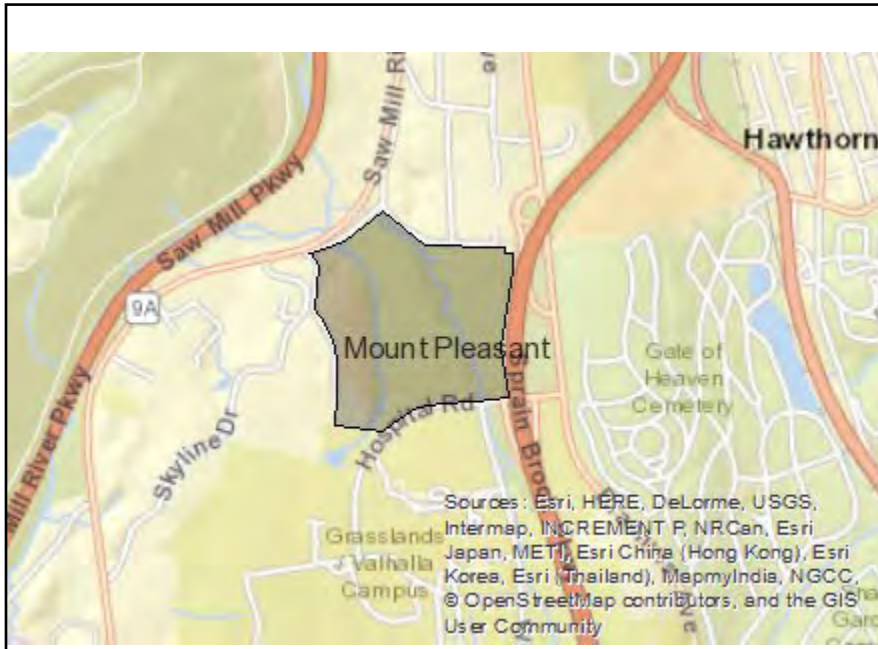

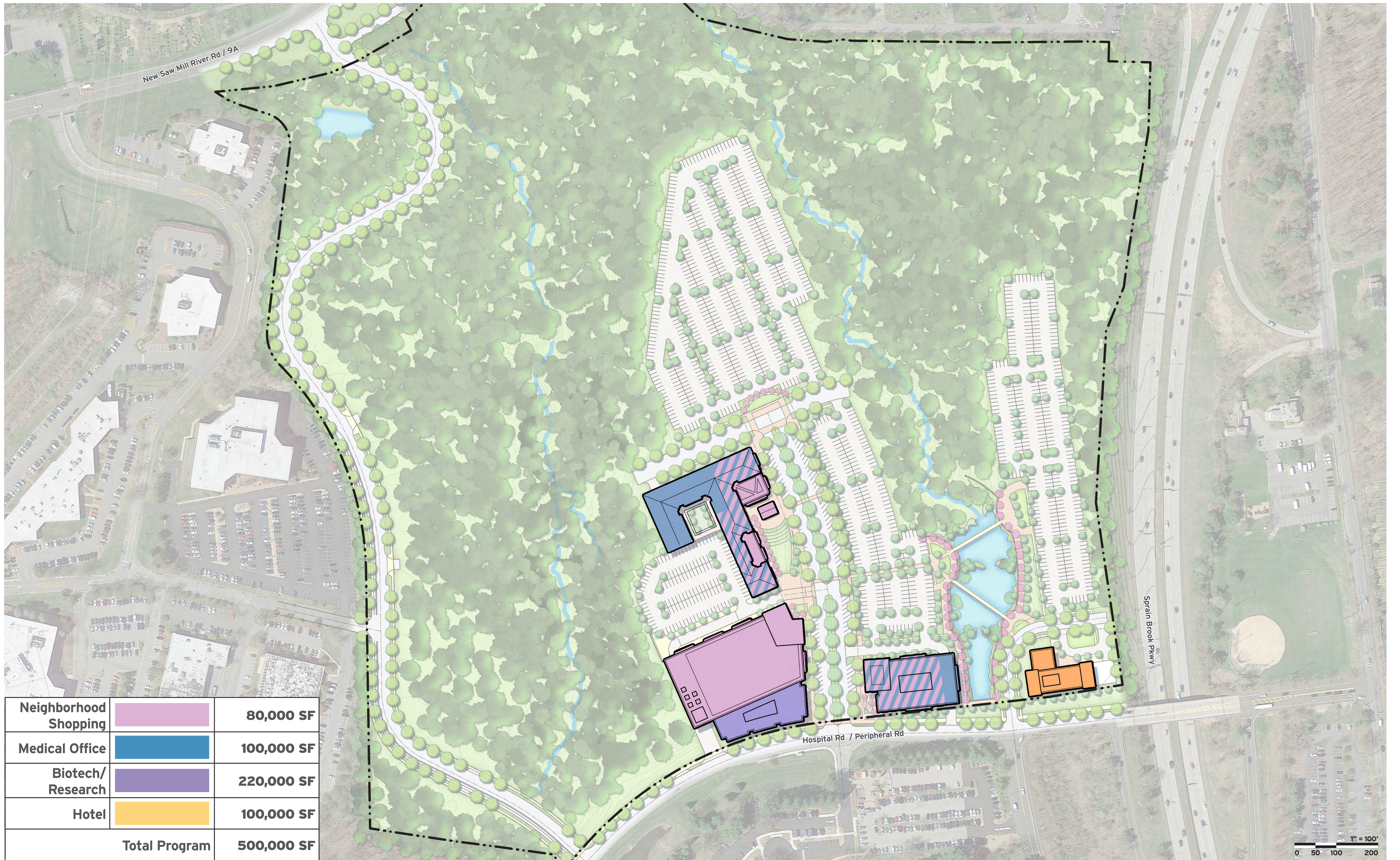


